<p>Alinea has produced Carbon Reduction Plans for both its Canadian and United Kingdom entities. This Carbon Reduction Plan, for Alinea Ltd (a UK Entity), consists of emissions associated with Alinea’s UK operations, was completed in accordance with Greenhouse Gas Protocol’s Corporate Accounting and Reporting Standard using the operational control consolidation approach. Scope 3 emissions were included for the following categories: upstream transportation and distribution, downstream transportation and distribution, business travel, homeworking, employee commuting, water treatment and supply, waste generated in operations, and transmission and distribution losses from Scope 2 energy.</p> <p>The assessment, carried out in accordance with the PPN 0621, found no GHG emissions associated with Alinea Ltd’s operations on UK territory. Since Alinea Ltd currently has no physical offices in the UK and only operates via subcontractors, which fall outside the scope of the PPN 0621 Carbon Reduction Plan, the GHG emissions associated with Alinea Ltd’s UK operations are 0 tCO<sub>2e</sub> as shown below. Alinea Ltd’s operations will continue to be assessed to determine if any future GHG emissions associated with operations on UK territory will eventuate and if so report them in the PPN 0621 Carbon Reduction Plan.</p>


