The Programme Management Unit for the Good Governance Fund (GGF) designs, procures, and supervises rapid, responsive technical assistance to mobilise reforms in Ukraine.

Building capacity within key ministries supports the Government of Ukraine's ability to reduce corruption; promote transparent and accountable institutions; and build an open, inclusive economy and society.

In wartime, the team supports the Government with modelling of energy supply and demand to keep the lights on for Ukrainian citizens; managing public finances; and quantifying the cost of war damages in support of effective recovery planning.

Business Revitalisation

Only 13 per cent of SMEs continue to work at full capacity, in line with general business trends. More than 25 per cent of SME business owners report a lack of reserve funds. SMEs are a key source of tax revenue and economic growth for Ukraine, and therefore a crucial sector to support survival through the conflict and preparations for economic recovery. Recognising insufficient resources and capacity to support SMEs, the Government required evidence-based and context-specific technical assistance in the areas outlined below. The GGF Programme Management Unit helped meet these needs through cooperation with key stakeholders, including Ukraine's Ministry of Digital Transformation, Ministry of Economy, and Export & Enterprise Promotion Office.

Areas of Focus

- Revise the SME support policy framework
- Reshape SME institutional support platforms
- Redesign and deliver target support programmes

Public Finance Management

The ongoing conflict puts Ukraine's economic stability at risk, requiring conflict-sensitive macroeconomic scenarios and policy options. Analytical tools, strategic advice, and communication support are central to fortifying Ukraine's economic resilience throughout the current conflict and post-war recovery. The Government required evidence-based and context specific technical assistance in the areas outlined below. The GGF Programme Management Unit helped meet these needs through cooperation with key stakeholders, including Ukraine's Ministry of Economy and Ministry of Finance.

War Damage & Recovery Cost Assessment

Ukraine faces the challenge of assessing large-scale damage caused by the war and Russian aggression, which requires a unified, evidence-based approach. Losses range from human and economic to social, environmental, and institutional. Recognising a gap in knowledge and resources to collect and analyse this data, the Government required evidence-based and context-specific technical assistance in the areas outlined below. The GGF Programme Management Unit helped meet these needs through cooperation with key stakeholders, including Ukraine's Ministry of Infrastructure, Ministry of Economy, and Ministry of Reintegration of the Temporarily Occupied Territories.

Areas of Focus

- Integrate damage assessment into government recovery planning
- Build capacity to operate geographic information systems (GIS) for damage and loss assessment
- Standardise methodologies to assess war-related damage and loss

Key Results

Both before and subsequent to the full-scale invasion of Ukraine, the GGF Programme Management Unit has applied its collaborative methodologies and the skills of its diverse and highly qualified team to achieve the following results:

Rebuilding & Modernising Energy Infrastructure

The war's impact on critical infrastructure is compromising Ukraine's energy capacity. Supply is at risk for businesses, households, and EU energy transit, exacerbated by gas supply restrictions imposed by Russia. Recognising a gap in policymaking to navigate this complex landscape, the Government required evidence-based and context-specific technical assistance in the areas outlined below. The GGF Programme Management Unit helped meet these needs through cooperation with key stakeholders, including Ukraine's Ministry of Energy, Office of the President, and National Energy and Utilities Regulatory Commission.

Areas of Focus

- Develop the National Recovery Plan for Ukraine
- Increase participation and knowledge sharing through cooperation across the Ministry of Energy
- Design a detailed roadmap for representatives of the Ministry of Energy to ensure quality implementation

Key Results

Design & Implementation of Recovery Plans

Unclear regional priorities, lack of unified data collection approaches, and insufficient large datasets are constraining comprehensive recovery planning. War-related challenges are limiting stakeholder engagement and public consultation, combined with increasing social friction caused by the rapid increase of IDPs. Recognising limited technical, administrative, and project management capacity, the Government required evidence-based and context-specific technical assistance in the areas outlined below. The GGF Programme Management Unit helped meet these needs through cooperation with key stakeholders, including Ukraine's Ministry of Communities, Territories and Infrastructure Development, as well as Kyiv City State Administration.

Areas of Focus

- Collect data from 1100+ communities
- Create 15 institutional support platforms
- Complete assessment of healthcare assistance and system support
- Develop a Recovery Framework for Kyiv City
